

CONNECTICUT ENG/LS FREQUENTLY ASKED QUESTIONS

Q. Does the PCS deadline for scheduling and paying apply to the board application deadline?

A. No. Please check with the Connecticut Board of Professional Engineers and Land Surveyors for the board application deadline. It may be sooner than the PCS scheduling and payment deadline.

Q. Why are the deadlines different?

A. The board must first process your board application before you will be allowed to schedule and pay for the examination. Upon approval of eligibility to take the examination, the board will mail you an approval letter. The board's deadline is for the board application. The PCS deadline is the same as NCEES for registration.

Q. I am a Connecticut applicant. Can I take the examination in a state other than Connecticut?

A. No, proctoring into another state other than the state in which you applied to take the examination is no longer available unless you are military. If you have military orders, please contact NCEES to apply for this accommodation.

Q. I have been approved to take the examination in another state (other than Connecticut). Can I take the examination in Connecticut?

A. No, proctoring into another state other than the state in which you applied to take the examination is no longer available unless you are military. If you have military orders, please contact NCEES to apply for this accommodation.

Q. How can I receive confirmation that I am scheduled and paid with PCS?

A. You may log onto your PCS account to check your status 24 hours a day. Click on Applicants & Candidates, choose Login at the bottom and then follow the prompts. Also, PCS sends you a confirmation email once you are registered and scheduled for your examination.

Q. When will I receive my admission packet from PCS?

A. Approximately 2-3 weeks prior to the exam, NCEES will email you information regarding your Exam Authorization. The Exam Authorization will contain your exam date, time, specific testing location and other valuable exam related information. You are required to print your admission materials and take them to the examination with you for admittance.

Q. What more can you tell me about the examination?

A. For information concerning the examination content, scoring information and national pass rates please visit the National Council of Examiners for Engineering and Surveying (NCEES) web site, www.ncees.org.

Q. When can I expect to receive my examination score?

A. Professional Credential Services (PCS) expects to receive candidate scores from the National Council of Examiners for Engineering and Surveying (NCEES) approximately 10-12 weeks after the examination. Upon receipt of candidate scores, PCS will notify the board. The board will vote on a release date at their next board meeting. Once approved for release, PCS will be notified and inform NCEES to release the results to all candidates.

Q. Fourteen weeks have passed since the exam, why haven't I received my score?

A. Once scores have been released; you will receive an email from NCEES. When you receive that email, you may log onto your NCEES account to view and print your score notice. Score notices are no longer mailed.

Q. How can I receive a receipt of my fees paid to PCS?

A. Candidates who wish to receive a receipt from PCS may do so by logging onto their PCS account. You may view or print a receipt 24 hours a day.
