#### INTRODUCTION

The Board of Examiners of Engineers, Architects, and Surveyors of Puerto Rico has engaged Professional Credential Services (PCS) for application processing, examination administration, and grade reporting. Please read the following information carefully before completing the enclosed application form. All inquiries regarding the examination must be directed to the Puerto Rico Coordinator at Professional Credential Services. Applicants should not contact the Board office except regarding certification and licensure.

ALL CANDIDATES ARE REQUIRED TO CREATE AN ACCOUNT AND REGISTER WITH NCEES AT WWW.NCEES.ORG. YOU WILL NOT BE ABLE TO SCHEDULE AND PAY FOR THE EXAM WITH PCS WITHOUT DOING SO. YOU MUST REGISTER WITH NCEES EVERY TIME YOU WANT TO SIT FOR AN EXAM.

Exam types/disciplines CAN NOT be changed after the NCEES registration deadline, no exceptions. Your exam selection on your NCEES account will dictate the examination booklet ordered for you. To change your selection *before* the NCEES registration deadline, you must 1) log into your NCEES account and change your selection and 2) send an email to preng@pcshq.com with your new selection.

#### FIRST TIME APPLICATIONS

The same application form is provided for the following examinations: 1) Fundamentals of Engineering (FE); 2) Principles & Practice of Engineering (PE); 3) Fundamentals of Surveying (FS); and 4) Principles & Practice of Surveying (PS). Be certain to indicate on the enclosed application for which examination you are an applicant.

First-time candidates are those who:

- have not completed an application with PCS as a Puerto Rico candidate; or
- have not taken the examination since October, 1998 as a Puerto Rico candidate; or
- have previously taken the examination for another jurisdiction.

Completed applications must be received by Professional Credential Services by January 31<sup>st</sup> for the April 2013 examination and July 15<sup>th</sup> for the October 2013. Educational documentation must be received no later than February 21<sup>st</sup> for the April 2013 exam and no later than September 5<sup>th</sup> for the October 2013 exam. Applications will not be accepted after the deadline for any reason. Please read below for required documentation for first time examination approval.

#### <u>ALL First Time Candidates must meet these</u> requirements based on the exam they wish to take.

**FE Only** -Certificate of Enrollment (last 32 credit hours), Certificate of Completion/Graduation or Official Final Transcript with the Conferred Degree Date.

**FE & PE** -Certificate of Completion/Graduation or Official Final Transcript <u>with</u> the Conferred Degree Date.

**PE Only** -Certificate of Completion/Graduation or Official Final Transcript <u>with</u> the Conferred Degree Date.

#### **RE-EXAM SCHEDULING**

All Re-Exam candidates **MUST** have a Certificate of Completion/Graduation (COC) or an Official Final Transcript with degree conferred in their files before they can retake an examination. Student copied or uploaded documents are NOT acceptable. Only original documentation send directly from the institution will bee accepted for re-exam approval.

- You must register with NCEES at www.ncees.org between December 17<sup>th</sup> and February 21<sup>st</sup> for the April 2013 examination and between June 17<sup>th</sup> and September 5<sup>th</sup> for the October 2013 examination.
- Schedule and pay online at www.pcshq.com between December 17<sup>th</sup> and February 21<sup>st</sup> for the April 2013 examination and between June 17<sup>th</sup> and September 5<sup>th</sup> for the October 2013 examination.

You are a re-examine candidate **only** if you have taken an examination with Professional Credential Services since October 1998.

#### VERIFICATION OF RECEIPT OF APPLICATION

*First-Time* candidates Do NOT contact Professional Credential Services to verify receipt of your application. Send your application certified mail, return receipt requested or express mail, return receipt requested.

*Re-exam* candidates that schedule and pay over the internet will be able to print a receipt of payment.

#### **PE STRUCTURAL APPLICANTS:**

The 16 hour PE Structural exam will be offered for the first time in April 2011. It is a breadth and depth exam offered in two components on successive days. The 8-hour Vertical Forces (Gravity/Other) and Incidental Lateral component is offered only on Friday and focuses on gravity loads and lateral earth pressures. The 8-hour Lateral Forces (Wind/Earthquake) component is offered only on Saturday and focuses on wind/earthquake loads. Candidates must receive an acceptable result on both components within a 5-year period. For more information, please visit www.ncees.org.

*First-Time* candidates payment must be by certified check or U.S. money order (NO personal checks) made payable to Professional Credential Services/PR ENG. The candidate's NCEES ID number must be posted on the certified check or money order and mailed along with the first time application.

*Re-exam* candidates may pay and schedule online at <u>www.pcshq.com</u> with Visa, MasterCard or Discover.

#### **REFUND POLICY**

FEES WILL **NOT** BE REFUNDED OR TRANSFERRED TO FUTURE EXAMINATIONS FOR ANY REASON. **NO EXCEPTIONS**. CANDIDATES CAN CANCEL AN EXAMINATION BUT THEY WILL FORFEIT THEIR FEES.

#### **ELIGIBILITY FOR EXAMINATION**

In order to qualify for the examination, applicants must:

- be of good moral character; and
- Be a legal resident of the Commonwealth of Puerto Rico; and a U.S. Citizen.
- have a baccalaureate degree in science from an accredited U.S. academic institution and completed an engineering program that is recognized by the Higher Education Council of Puerto Rico or by the Accreditation Board for Engineering and Technology (ABET).

<u>Note:</u> If you are NOT a resident of the Commonwealth of Puerto Rico, and you reside in the United States, the Board allows you to sit for the examination but you will not be certified or licensed. Only legal residents of the Commonwealth of Puerto Rico will be able to request certification or licensure for this Jurisdiction.

#### Puerto Rico does NOT accept Technology degrees of any kind.

**FOREIGN EDUCATION:** Candidates, who received their bachelor's degree from a school outside of the United States and want to qualify based on education, MUST have their education credentials evaluated by the NCEES CREDENTIAL EVALUATIONS. The original evaluation must be mailed or emailed directly to PCS from the evaluation company. The candidate must ensure everything is mailed to Professional Credential Services by the entry deadline. Josef Silny & Associates evaluations are <u>NO</u> longer accepted.

#### EVIDENCE OF QUALIFICATIONS

Candidates who are in their last semester or trimester of enrollment in a baccalaureate degree program must arrange to have the enclosed Certificate of Enrollment (COE) indicating work in progress completed by the Registrar. The COE must be returned by the application deadline. Official academic transcripts (only if degree has been conferred on transcript) must be submitted directly to Professional Credential Services from the institution.

Candidates who have completed coursework and have not received the diploma may submit an official Certificate of Completion (COC) verifying the course completion and baccalaureate degree conferral. After graduation, the candidate **must** arrange for final transcripts to be mailed directly from their academic institution to Professional Credential Services after the degree has been posted. Official evidence that the educational requirements have been met must be received for the completion of your file and for release of scores.

#### MATERIALS TO BE SUBMITTED

All candidates must submit the following materials by the application deadline:

- 1. Completed, signed and notarized application with a "2x2" photograph attached;
- Certified check or U.S. money order made payable to PCS for examination fees. Please record the social security number on the certified check or money order;
- 3. Certificates of Good Moral Character completed by three references that are licensed professional engineers/surveyors in good standing. (License cannot be expired).
- FE Only-Certificate of Enrollment (last 32 credit hours), Certificate of Completion/Graduation or Official Final Transcript <u>with</u> the Conferred Degree Date.

**FE & PE** -Certificate of Completion/Graduation or Official Final Transcript <u>with</u> the Conferred Degree Date.

**PE Only** -Certificate of Completion/Graduation or Official Final Transcript with the Conferred Degree Date.

#### NCEES

All candidates are required to create an account and register with NCEES before scheduling and paying for the exam with PCS. If you have already created an account, you MUST register by logging back into your account at <u>www.ncees.org</u> for each exam cycle you sit for. Candidates must visit the National Council of Examiners for Engineering and Surveying web site (www.ncees.org) to register. Candidates are also encouraged to visit the website for the latest information on calculators. Puerto Rico will strictly adhere to the NCEES recommendations/guidelines regarding the calculator policy. NCEES also lists the exam dates for the next 10 years.

#### **EXAMINATION RULES AND CONDUCT**

Candidates must bring a government issued ID to the examination for admittance. The government issued ID must contain the candidates name as it appears on the admission card. The ID must include a recent photo, date of birth, expiration date and signature. If a military ID does not contain the candidate's signature, a secondary ID with a signature is required for admittance. Student ID's and expired ID's are not acceptable. Candidates are expected to exhibit proper examination decorum throughout the examination. Candidates will be required to arrive at least thirty minutes prior to the scheduled time for each examination section. Candidates will not be admitted to the examination after the announcements have been given for that examination section. Detailed instructions concerning arrival will be included with the admission ticket. Only bound reference books will be allowed in the examination room during the PE and PS examinations. During the FE examination, only the NCEES-supplied Reference Handbook will be permitted in the examination room. The Reference Handbook will be distributed to candidates on examination day. Candidates may request a copy of the Reference Handbook prior to the examination by contacting NCEES (1-800-250-3196) or may download and print the materials from the NCEES web site (www.ncees.org).

#### **ENGLISH NOTE**

Instructions at the examination are given in Spanish at the Puerto Rico examination site. If you do not understand Spanish please contact PCS immediately so that English announcements can be provided for you.

#### SPECIAL ACCOMMODATIONS

In accordance with the provisions of the Americans with Disabilities Act (ADA), examination administration modifications are available for candidates who qualify. Also, candidates who are members of religious faiths that cannot take the examination on the designated date are permitted to take the examination on the Monday, following PR CIB 02252013

the national examination date. Accommodations must be requested and approved by NCEES. Please go to the NCEES web site (www.ncees.org) to read complete information as to the application procedures for special accommodations.

ALL REQUESTS AND DOCUMENTATION ARE DUE BY THE REGISTRATION DEADLINE.

Please note that the mailing addresses for the requests vary by the type of request you are making. The correct mailing address is on each specific report.

#### NOTIFICATION OF EXAMINATION ADMISSION

Candidates must allow four weeks for full processing of their examination application. Approximately two to three weeks prior to the examination, NCEES will email an exam authorization to eligible candidates and will include dates, times, and location of the examination. If the exam authorization has not been received within seven days prior to the examination date, the candidate must contact Professional Credential Services.

#### NAME OR ADDRESS CHANGES

Any name or address change must be reported in writing to Professional Credential Services. Name changes must be received by PCS on or before the NCEES deadline. Be sure to include your name as it appears on your application, NCEES ID number and copies of any court documents if applicable. Name or address changes may be emailed to PCS at preng@pcshq.com. Candidates must also notify the Board of any name or address change.

#### RESULTS

Results will be posted on your My NCEES account (<u>www.ncees.org</u>) for all candidates approximately 10 to 12 weeks after theexamination. NCEES will email candidates a link when the result has been released. Candidates do not receive numeric scores for the FE/PE/FS/PS examinations, just a Fail or Pass. Results will not be given over the phone. Please do not call either the Puerto Rico Board Office or PCS for test results.

#### SCORE VERIFICATIONS

Score verifications will be available on our web site for a limited time. An additional fee will be charged for this service. Visit our web site for additional information about score verifications.

#### PCS CONTACT INFORMATION

Professional Credential Services staff is available by telephone Monday through Friday between 7:00 am and 4:30 pm, central time. Applications must be submitted by regular mail or by express mail of the U.S. Post Office. Deliveries from express services other than the U.S. Postal Service cannot be accepted in a post office box.
